Chris Rodgers' Campaign for NACo 2nd Vice President Receives Support from California and Missouri

Court Upholds Assessors' Method of Valuation

Today (June 11), the Nebraska Supreme Court issued Schuyler Apt. Partners v..Colfax Cty. Bd. of Equal., 279 Neb. 989, --- N.W. 2d--- (2010). The Court upheld decisions by the Tax Equalization Review Commission (TERC) associated with low-income housing. TERC had affirmed decisions by two counties related to the value of the property. Also of note, the Court rejected Schuyler Apartment Partners' position that Neb. Rev. Stat. § 77-1333 requires that property be valued by the income approach. The Court highlighted that the statute provides in part, "that the 'county assessor, in determining the actual value of any specific property, may consider other methods of determining value,' including the cost approach and the sales approach."

2010 Budget Workshop Well Attended

One-hundred participants representing 54 counties were in attendance in Kearney on May 27th in attendance at NACo's Budget Workshop, which is held biennially.

Speakers included representatives from the Nebraska Auditor of Public Accounts office, the City of Lincoln, and various county officials and staff.

County Budget Handbooks were provided to attendees of the workshop. There are a few handbooks still available for \$25.00 plus \$5.00 for shipping and handling. An overview of the various budget and levy statutes is included within the book. Also, there is a copy of forms and other items of benefit to counties as they prepare the upcoming budget.

Secretary of State John Gale has announced the availability of a free online course, *The Introduction to Records and Information Management*.

Developed by the Intergovernmental Preparedness for Essential Records (IPER) project, with the support of the Federal Emergency Management Agency (FEMA), the course is designed to focus on the records and information management practices fundamental to the efficient and economical operations of any government agency.
