

Legislature Convenes on January 7, 2009

The 101st Legislature, First Session convened last week for a "long" 90-day session. Bills that were not adopted during the 2008 session were killed. Senators have 10 days to introduce new bills. By the end of the seventh day, 355 new bills and three constitutional amendments had been introduced. Adjournment is tentatively scheduled for June 4.

Senator Mike Flood was re-elected speaker. The following senators were elected to chair standing committees: Sen. Tom Carlson – Agriculture; Sen. Lavon Heidemann – Appropriations; Sen. Following a recess day in recognition of Martin Luther King, Jr. Day, committee hearings are scheduled to begin on the afternoon of Jan. 20. A list of selected hearings of interest to counties is listed on the reverse. All bills must have a public hearing before a standing committee. If the committee advances the bill to the full legislature, it is subject to three rounds of debate: General File, Select File and Final Reading. Bills that are adopted on Final Reading are sent to Governor Heineman for a signature or veto.

NACO Offers Jail Reimbursement Replacement

After several years of struggling to retain partial reimbursement for counties holding state prisoners, a bill has been introduced on NACO's behalf to replace jail reimbursement, state aid to counties, and the County Property Tax Relief Program with a single aid computation. Under **LB 218**, the Legislature would appropriate funds in an amount equal to a percentage of the total real and personal property valuation of all counties. The percentage would be capped at.0125 percent and could not be less than .0075 percent of total valuation. Each county would receive \$30,000 and the rest of the funds would be distributed on a ratio of each county's valuation compared to the total state valuation. The calculation would be made by the Tax Commissioner and distributed to counties in nine equal monthly payments beginning in September each year.

County jail reimbursement was developed by NACO and adopted in 1998. Counties are reimbursed \$35 per day for

holding state prisoners. Although the initial funding was much greater, the current \$3.9 million annual Legislative appropriation is typically depleted during the third quarter, so counties holding state prisoners in the final months of the year are not reimbursed. When the plan was enacted, the County Property Tax Relief Program was added to provide funds to smaller counties that hold fewer state prisoners. Funding was eliminated during a downturn in the state budget several years ago and reinstated in 2007 under a revised formula that included need.

State aid to counties, while statutorily set at \$13.5 million, has been appropriated at a level of slightly less than \$5 million since FY 03-04.

No hearing date has been set for LB 218, which was introduced by Sen. Abbie Cornett, chair of the Revenue Committee, and cosigned by Sen. Lavon Heidemann, chair of the Appropriations Committee.

Inheritance Tax Changes Proposed

Inheritance taxes are back on the table under a proposal that will be heard by the Revenue Committee on January 22. **LB 119** would decrease the tax rate for Class 2 beneficiaries, including uncles, aunts, nieces, nephews and their spouses, from 13 percent to 10 percent. The tax is imposed on amounts in excess of \$15,000. The change would apply to all property which passes

from a decedent dying on or after Jan. 1, 2009. As in past years, NACO is collecting data on the total amount of inheritance taxes collected by each county in the past year and how it was used in order to emphasize the importance of inheritance taxes to counties.

NACO Board Approves 2009 Scholarship Program

The NACO Board of Directors has again voted to make twelve \$1,000 scholarships available to the children and stepchildren of county officials and employees. Students must be seniors attending a Nebraska high school and plan to further their

education within the state. The deadline for applications is March 2, 2009. Application forms are available under the Services tab on the NACO website www.nacone.org or by calling the NACO office at 402-434-5660.
