ARPA–State and Local Fiscal Recovery Funds

Counties will be required to submit one interim report, which will include the county's expenditures by category at the summary level. The interim report will cover spending from the date the county receives Recovery Funds to July 31, 2021. Interim reports are due by August 31, 2021. Please note as of July 29, 2021 the U.S Treasury has not released the User Guide on how to submit the interim report. Once the user guide is released, NACO will notify county officials via email. In the meantime, the Compliance and Reporting Guidance Report as well as webinars are available for your review.

The NACO Board of Directors has directed NACO staff to seek professional services for counties that will assist in services such as strategic planning, consulting, compliance, reporting, internal control development, grant monitoring and single audit. We are currently in the process of interviewing audit firms and will have more information coming soon on professional services that are considered an eligible expense. In addition, NACO is compiling additional resources to assist counties in utilizing the SLFRF.

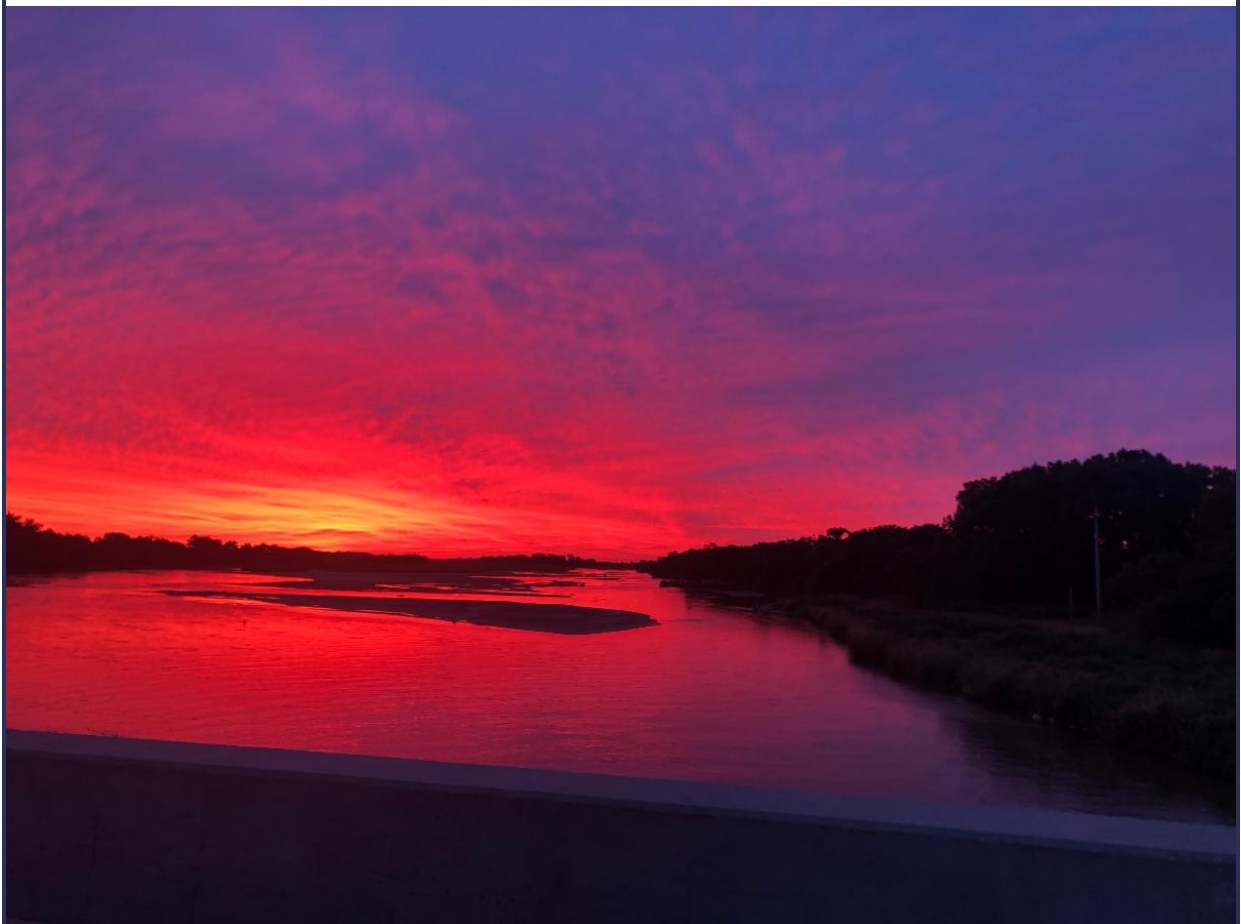
