## Inheritance Tax Proposal set for Feb. 13 Hearing

Despite a lack of data on the changes made by last year's inheritance tax legislation, a bill has been introduced that would reduce the amount of inheritance taxes paid by certain beneficiaries. **LB 913** would reduce inheritance taxes paid by aunts, uncles, nieces and nephews to 10 percent of the value of the property in excess of \$15,000. Last year's legislation set the tax at 13 percent on amounts in excess of \$15,000, effective Sept. 1, 2007. The Revenue Committee will take public testimony on the bill on Wednesday, Feb. 13 at 1:30 p.m. in Room 1524 of the State Capitol. NACO opposes LB 913.

At the same hearing, the committee will also take testimony on two bills that would exempt the first \$25,000 of a home's value from property tax. **LB 732** would provide the exemption for single-family residential property and would require the passage of a constitutional amendment, **LR 220CA**. **LB 733** revises existing homestead exemption laws that reimburse counties and other local governments for property tax reductions granted to the elderly, disabled, and veterans. **LR 230CA** would create a homestead exemption on the increased value of a residence

owned by persons over 65 years of age who have an income of less than \$40,000. **LB 1026** would exempt real and personal property in which a housing agency has an interest from all taxes and special assessments of counties, cities, the state or any public agencies.

On Feb. 20, the Revenue Committee will hear a bill to require counties that have transferred the assessment function to the state to reassume the office by July 1, 2011 (**LB 1008**). Other bills set for hearing that day would change the membership on the Tax Equalization and Review Commission (**LB 1111**) and replace it with a tax court (**LB 1110**). A constitutional amendment, **LR 231CA**, that would replace the Commission, was withdrawn. **LB 1039** would create a task force to develop an income approach for valuing ag land. **LB 1118** would require governing bodies to file a statement noting the amount that would be raised if a proposed levy was applied to the prior year's valuation.

## Jail Reimbursement Prioritized by Sen. Aguilar

A bill to remove the statutory cap on state appropriations for jail reimbursement, **LB 587**, was prioritized by Sen. Ray Aguilar this week. Existing law prohibits the state from allocating more than \$3.91 million annually to reimburse counties for holding state prisoners. Although removal of the cap would not

guarantee that counties would be fully reimbursed, it would give the state the ability to appropriate an amount nearer to the \$8 million that counties were owed last year. Senator Abbie Cornett introduced the bill last year. The bill is in the Appropriations Committee.

## **One-Stop Motor Vehicle Bill Killed**

A proposal to require all counties to complete motor vehicle titling, registration and other transactions in a single county office has been killed by the Transportation and Telecommunications Committee. **LB 910** was one of five motor vehicle bills heard on Monday. The others, including two NACO bills and a bill to allow dealers to participate in registering vehicles (**LB 709**), remain in committee.

On Feb. 4, the committee will take testimony on a bill to allow dealers to use additional reassignment forms, **LB 841**, and a

measure to implement REAL ID. **LB 911** proposes 27 DMV regional service centers and central issuance of drivers licenses and state IDs.

Tree trimming and mowing of county right of way will be discussed on Feb. 11. Sen. Lavon Heidemann introduced language in **LB 1051** that is identical to wording proposed by NACO in 2006. The bill would change the dates for landowners to mow ditches and increase the height to which trees must be trimmed from 8 to 15 feet to accommodate larger vehicles.
